Item 4: An ordinance setting the tax rate at 79.70¢ per \$100 valuation and levying ad valorem taxes for the City of Dallas, Texas for FY 2012-13 - Financing: No cost consideration to the City

Mayor Pro Tem Medrano read the following statement:

State law specifies particular language for the motion to adopt the FY2013 tax rate. The tax rate for each \$100 of property value remains unchanged from FY2012 to FY2013, but the city will receive increased property tax revenues due to the growth in the overall tax base.

Mayor Pro Tem Medrano moved to adopt the property tax rate of  $79.70\phi$ , which is effectively a 0.75% increase in the tax rate.

Motion seconded by Deputy Mayor Pro Tem Atkins and unanimously adopted.

Later in the meeting, the assistant city secretary announced State law requires a record vote for this item.
