Item 3: First reading of the appropriation ordinances for the proposed FY 2014-15 City of Dallas Operating, Grants/Trusts, and Capital Budgets; and to include discussion - Financing: No cost consideration to the City

Mayor Pro Tem Atkins moved to adopt the item with amendments to be read into the record by Councilmember Griggs.

Motion seconded by Councilmember Griggs, with the following amendments:

Amendment #1:

Source of Funds: \$1,025,000

- \$450,000 estimated revenue available from City sponsorship of private vendor that offers water/sewer line home warranty to residents
- \$575,000 reduction in service #5.36 (Master Lease Program)

Use of Funds: \$1,025,000

- \$300,00 for libraries
- \$225,000 for Cultural Affairs Commission in the arts
- \$100,000 for senior dental program
- \$100,000 for Earned Income Tax Credit program
- \$300,000 for Dallas Animal Services

Amendment #2:

Source of Funds: \$500,000

- \$200,000 for the reduction of service item #5.4 [Analysis/Development and Validation]
- \$100,000 for the reduction of service item #5.40 [Human Resources Consulting]
- \$88,000 for the reduction of service item #5.48 [Payroll] [\$88,903]
- \$60,000 for the reduction of service item #5.53 [Strategic Customer Service] [\$60,006]
- \$51,000 for the reduction of service item #5.49 [Public Information Office] [\$51,091]

<u>Use of Funds: \$500,000</u>

- \$450,000 to create a contingency reserve that set funds aside in case the City Manager needs funds for the above reductions or for the implementation of technology improvements. In the instance the City Manager needs to access the funds, City Council approval would be required.
- \$50,000 for Pilot Program for Parks

Amendment #3:

Source of Funds: \$2,000,000

• \$2,000,000 will be from the additional surplus of general funds identified by the City Manager's Office

Use of Funds: \$2,000,000

- \$1.800.000 to increase reserve fund balance
- \$200,000 to increase contingency reserve and set funds aside for programing that mitigates poverty; programing to be subject to approval by City Council.

Councilmember Gates stated for the record the city is not taking care of its streets and there is not really a way to find enough money. The City Manager has stated the largest solution is going to be the next bond election. Although, I believe there are other things we can do to allocate funds for streets. We can look at the way streets are evaluated and its funds are appropriated, giving us the greatest impact in the near future. I would like to see more money in next year's budget. Also, next year the city should look at our streets infrastructure more closely. However, I am pleased that money for streets has been budgeted for the quality of life of our citizens and will directly impact the services we use every day.

Mayor Rawlings called the vote on Mayor Pro Tem Atkins motion to adopt the item with amendments read into the record by Councilmember Griggs. Mayor Rawlings declared the motion adopted. (Davis absent when vote taken)

Mayor Rawlings stated due to the unanimous vote on the item, the City Council Budget Workshop meeting scheduled for September 9, 2014 was cancelled; there was no objection voiced.
