Item 1: Receive the report of the Ad Hoc City Council Canvassing Committee and adopt a resolution and order accepting the Canvassing Committee's report declaring the results of the November 6, 2018 general election for the purpose of electing a member of the City Council to represent Place 04 for the unexpired term ending June 17, 2019

Councilmember Greyson stated the following:

The Ad Hoc Canvassing Committee, which consisted of myself (Councilmember Sandy Greyson), Deputy Mayor Pro Tem Adam Medrano and Councilmember Jennifer S. Gates met earlier this afternoon to canvass the results of the November 6, 2018 general election.

On behalf of the Ad Hoc Canvassing Committee, I make the following report, a copy of which has been provided.

Based upon the statement of returns for the City of Dallas General Election held Tuesday, November 6, 2018, we find candidates for City Council Place 4 did not receive sufficient votes to be elected.

If no candidate for a particular office receives a majority of the votes cast for all candidates for that office in the first election, a runoff election for that office is required. The two candidates who received the highest number of votes are:

Carolyn Arnold King Keyaira D. Saunders

These results appear to be accurate and the Ad Hoc Canvassing Committee recommends the City Council adopt the resolution accepting the report.
