Dear Ms. Bethune:

The Texas Ethics Commission has received your "Amendment: Appointment Of A Campaign Treasurer By A General-Purpose Committee." The appointment became effective on the date referenced above. Please reference the account number you have been assigned on all correspondence and documents that you submit to the Ethics Commission.

As campaign treasurer of a General-Purpose Committee filing according to the monthly filing schedule, you must file a monthly report covering the period beginning the 26th day of each month and continuing through the 25th day of the following month. Each report must be filed not later than the fifth day of the month following the period covered by the report.

As campaign treasurer of the committee, you will remain subject to all Title 15 reporting requirements until you resign or vacate the position, you are removed from the position, or the committee is dissolved. See the enclosed guide to determine the actions that are necessary to relieve you of future reporting requirements. Please note that you must also provide written notice to the Ethics Commission of any change of mailing address not later than the 10th day after the date the change occurs. Additionally, you must provide written notice to the Ethics Commission of any other change of information required to be included in the committee's most recent campaign treasurer appointment not later than the 30th day after the date the change occurs.

Electronic Filing Requirement.

All persons filing campaign finance reports with the Texas Ethics Commission are required to file those reports electronically unless the person falls within one of the statutory exemptions. We have enclosed a packet containing important information about electronic filing. A person who is required to file electronically but who fails to do so is subject to late filing penalties.

Late Filing Penalties.

If a required report is determined to be late, you may be civilly liable to the state for \$100. We therefore urge you to retain and consult the Texas Ethics Commission 2002 Filing Schedule For General-Purpose Committees Filing Monthly. Although our office may send reminders of deadlines as a courtesy to our filers, the responsibility for remembering the deadlines remains with you. Failure to receive a courtesy reminder from this office before a deadline will not excuse a late filing. If you have questions about filing deadlines, please call our Legal Division.
