- Maintain existing water rights and fee structure to ensure water sustainability
- Support legislation related to climate and climate mitigation and adaptation actions
- Support legislation that advances the use of electric vehicles and related infrastructure



Quality of Life, Art and Culture



Support legislation that fosters clean and appealing neighborhoods while offering recreational, educational, and cultural activities that enhance the quality of life for our residents and visitors

- Maintain municipal authority related to development matters, including zoning and short-term rentals
- Legalize use of marijuana
- Remove fentanyl test strips from "paraphernalia" definition and classification
- Amend language in rental car tax to allow for the use for cultural centers, arts and parks



Workforce, Education & Equity Priorities



Support legislation that allows the City to be equitable, inclusive, and welcoming for all residents and visitors

- Ensure proper healthcare, including reproductive rights
- Support legislation to protect the rights of all vulnerable communities, including LGBTQIA+ individuals, and enforce non-discrimination against residents
- Increase funding for workforce readiness and pipeline programs to support vocational studies such as mechanic and HVAC careers

SUBJECT City Organizational Memberships

In preparation for consideration of renewal for the upcoming fiscal year, below you will find the current organizational memberships: National League of Cities, Texas Municipal League, United States Conference of Mayors, North Texas Commission Dallas Regional Mobility Coalition, and TEX-21.

National League of Cities (NLC) – Membership expires January 31, 2023

Annual Membership Fee: \$38,384 Member Benefits:

- NLC serves as a resource and advocate for the nation's cities and their leaders.
- NLC serves the interests of 19,000 cities, towns, and villages in the U.S. as well as professionals working in municipal government.
- NLC focuses on advocating cities' positions with federal lawmakers in Washington.
- NLC holds two annual conferences one in the fall in a different U.S. city, and one in the spring in Washington, D.C. Additional meetings and events are held as directed by the League's leadership.

Texas Municipal League (TML) – Membership expires October 31, 2022

Annual Membership Fee: \$59,542 Member Benefits:

- TML coordinates and advocates for a legislative program set by member cities at the state and federal level.
- TML has attorneys on staff to answer general legal questions about municipal law, and monitor federal and state laws and regulations, as well as city-related developments in the courts.

SUBJECT State and Federal Lobbyist Contracts for FY23

Each year, to facilitate City of Dallas legislative priorities and assist with tracking legislation that may affect the city, the City Attorney's Office retains the professional services of both state and federal lobbyists. To ensure a full complement of expertise and resources dedicated to these efforts, staff proposes consideration of the following contracts, which expire on October 31, 2022, for a one-year term, from November 1, 2022, through September 30, 2023.

The federal lobbyists:

 - Current Contract Amount: \$160,000
- Paul Schlesinger, Thor Run Partners
 - Current Contract Amount: \$74,375

The state lobbyists:

 Current Contract Amount: \$70,000

 O Current Contract Amount: \$60,000

The current lobbyist contracts for both state and federal lobbyists were briefed to City Council via memorandum on Friday, October 8, 2021, and were approved on Wednesday, October 13, 2021, for one-year terms that will expire on October 31, 2022. Renewal of the state and federal lobbyist contracts for the next fiscal year is tentatively scheduled for Mayor and City Council consideration on Wednesday, September 28, 2022.

In anticipation of various water infrastructure legislation, the City has also secured an additional lobbyist, Adam Burkland, whose sole focus will be on water related infrastructure legislation and initiatives. Similar to our other state lobbyists, this person will report to Clifford Sparks, the City's State Legislative Director.
