- Dallas plans to have enough reservoir firm yield to meet water demands equivalent to the 1950s drought of record
- Dallas' ranking for planned new water supply sources has been based on:
 - Costs capital construction and power

 - Likelihood for development
 - Treatability
- Water located closer to the City is generally less expensive
 - Lower infrastructure costs due to shorter pipelines
 - Lower pumping (energy) costs a recurring, annual expense


- Of the 1,365 unimproved alleys, 33 alleys were originally identified as possible candidates for "Alley to Trail" conversions.
- The FY 2022 Budget included \$4M of ARPA funds for this effort.

- The 33 alleys selected for further investigation for possible inclusion in the pilot conversion program met all or some of the following criteria:
 - No rear garage/entry to homes,
 - Identified area of inequity,
 - > High crime,
 - Frequent illegal dumping,
 - Publicly accessed facilities such as direct routes to schools, DART Stations, recreation centers, or parks,
 - > Fewer utilities,
 - Project feasibility.





CHALLENGES



- <u>Approval Phase</u> Constituent response time took longer than anticipated.
 Councilmembers stepped in to assist with outreach in some cases.
- <u>Materials</u> Due to the recent supply chain problem in the nation, sourcing various materials planned for use became limited, causing changes in surface treatments and delays in overall project completion time.
- <u>Landmark Commission</u> Eight alleys located in historic preservation areas required further review and approval action by Landmark Commission and associated Task Forces that placed conditions on approvals to modify materials, consequently altering the plan to deliver lighting in three alleys.
- <u>Dumping</u> During construction, areas were found with large amounts of garbage due to proximity to provisional shelters for unhoused populations causing property owners to deal with unusual amounts of garbage.



UPDATE



- Due to the nature of the project, as construction approached and various construction phasing components were highlighted, feasibility per location ultimately determined the locations requiring further elimination. Disqualification of alleys fell into categories such as: disapproval from property owners, properties with new rear access, inconsistencies found in property descriptions versus records, or utility conflicts. Therefore, 22 alleys were selected for conversion.
- As a final preparation step prior to mobilizing into construction, all qualifying alleys were surveyed by PBW Surveyors to identify right-of-way boundaries of all alleys.
- Construction of all those alleys is either currently underway or nearing completion. All "Alley to Trail" construction should be complete, weather permitting, by November 2022.
- Lighting materials were received the week of October 24, 2022.







Public Works has 1,185 projects planned for FY 2022 and through September 2022, of those projects 1,051 have been completed. Of the total \$172.6M programmed dollars for FY 2022, through September 2022, Public Works expended \$124.3M or 72.0% of total budget. In addition to the 1,051 projects completed through September 2022, there are a total of 73 projects currently under construction.

Amendments to the Dallas Fort Worth International Airport Code of Rules & Regulations [Paul Tomme, Legal Counsel, Dallas Fort Worth International Airport]

To the Honorable Members of the Transportation and Infrastructure Committee of the Dallas City Council:

Dallas Fort Worth International Airport (DFW) is requesting that the Owner Cities of Dallas and Fort Worth approve an amendment to DFW's Code of Rules and Regulations, which is detailed below. The 1968 Contract and Agreement between the Cities of Dallas and Fort Worth require that any amendments to the DFW Airport Code of Rules and Regulations be approved by both Owner Cities.

Chapter 2 Traffic Regulation

DFW is requesting approval of an amendment to Chapter 2 (Traffic Regulation) in Section 2-13 (Obedience to Signs) which will add a requirement that disabled veteran license plates and placards include the symbol of access adopted by Rehabilitation International in 1969 at its Eleventh World Congress on Rehabilitation of the Disabled in order to qualify for disabled parking at DFW Airport. This amendment will also bring DFW disabled parking regulations into compliance with the new Texas law requiring the international symbol for disabled parking. The Airport Board approved the Chapter 2 amendment at its October 13, 2022, meeting.

SEC. 2-13. OBEDIENCE TO SIGNS.

- (a) A person commits an offense if, as the operator of a vehicle, he stops, stands, or parks a vehicle within the boundaries of the Airport in violation of an official sign, curb marking, or street marking prohibiting, regulating, or restricting the parking, stopping, or standing of vehicles, except when necessary to avoid conflict with other traffic or to be in compliance with the law or the directions of a police officer.
- (b) A person commits an offense if he:
 - (1) is not a disabled person or transporting a disabled person and stops, stands, or parks a vehicle with a valid disabled person license plate, a disabled veteran license plate, a disabled parking placard, or a license plate or placard bearing the international symbol of access in a parking space or area designated specifically for the disabled;
 - (2) stops, stands, or parks a vehicle in a parking space or area designated specifically for the disabled without displaying that does not display a valid disabled person license plate, a disabled veteran license plate, or a disabled parking placard, or a license plate or placard each of which must bear bearing the international symbol of access in a parking space or area designated specifically for the disabled; or
 - (3) stops, stands, or parks a vehicle in such a manner that the vehicle blocks an access or curb ramp or any other architectural improvement designed to aid the disabled.
