- Financial capacity for 2024 General Obligation bond program is forecast to be approximately \$1 billion assuming \$200 million over five years of issuance.
- Analysis considers maintaining current debt service tax rate of 20.55¢ per \$100 valuation, continued payment of current outstanding debt, use of Commercial Paper as short-term just-in-time financing for bond program, issuance of remaining unissued 2017 General Obligation bonds, and annual issuance of Master Lease and/or Equipment Acquisition Notes for fleet and other equipment.
- Bond Election anticipates an over \$1 Million cost for a May 2024 bond election (share-cost feasible; if other referendums are being considered during this timeframe).

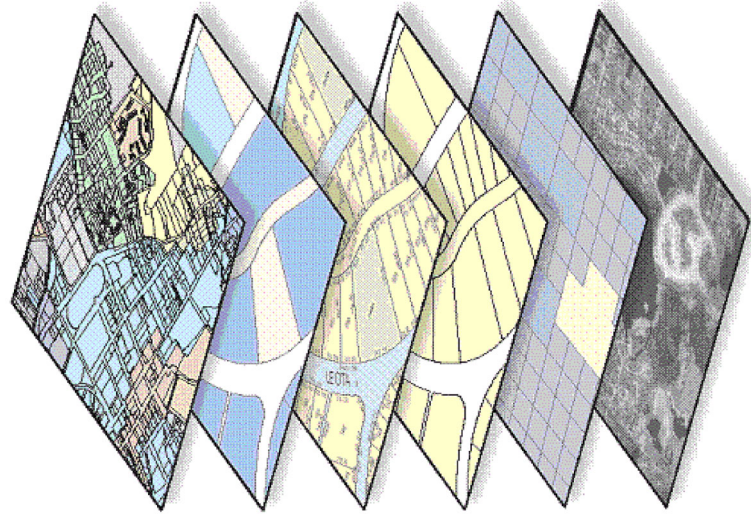

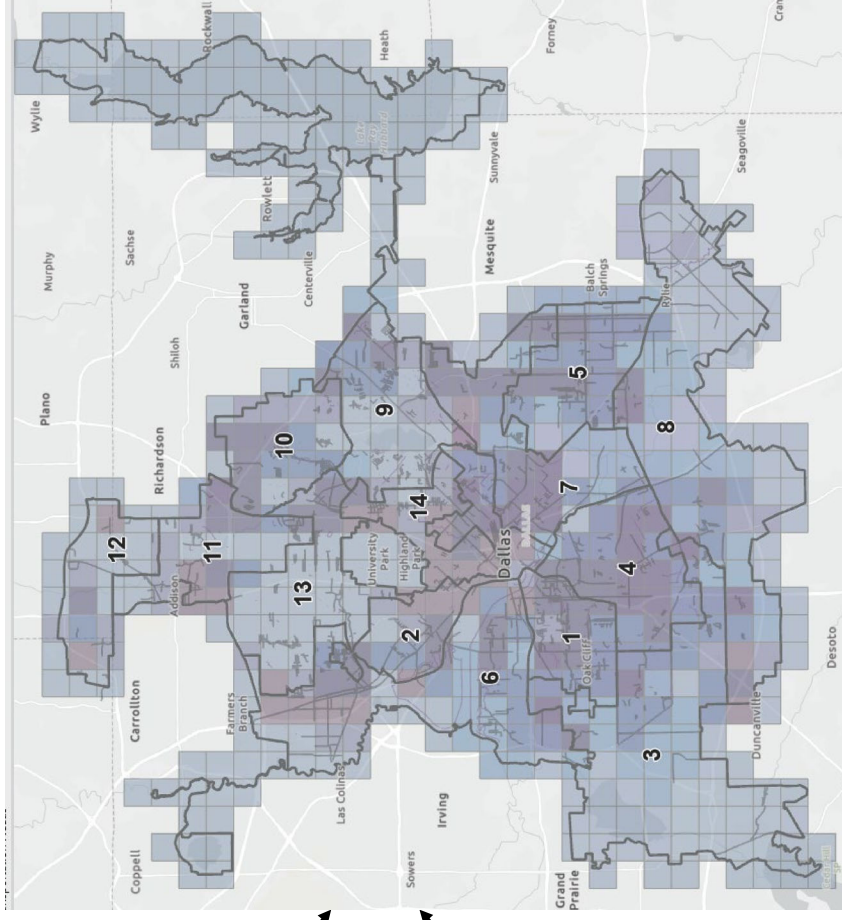

Background

As shared in previous memorandums to the Mayor and City Council on July 22, 2022, August 24, 2022, October 7, 2022, and December 8, 2022, and to the Transportation and Infrastructure Committee on September 19, 2022, the Dallas Area Rapid Transit (DART) Board of Directors (Board) had considered and ultimately approved allocations of excess sales revenues to its service area cities. Actions including, the DART Board approval of DART's FY 2023 annual budget on September 27, 2022, and acceptance of \$19.7M from the Regional Transportation and the North Central Texas Council of Governments on October 25, 2022, resulted in DART excess sales revenues, totaling \$111.1M, being allocated to the City of Dallas.

Whereas the intent of the \$111.1M excess sales tax allocation is to support DART's public transportation system or for complementary transportation services, the purpose of this memorandum is to provide recommended uses of the excess sales tax funds and discuss next steps.

Recommended Uses of DART Excess Sales Tax Revenues

Given the intent (support of DART's public transportation system or for complementary transportation services) of the \$111.1M excess sales tax funds and based upon discussion from the Transportation and Infrastructure Committee, staff recommends the following uses and allocations of funds:

Next Steps

As the recommended uses of the \$111.1M of DART excess sales tax revenues have been discussed, the following are next steps in the process:

1. Staff and legal review of a draft Interlocal Agreement (ILA) received from DART on December 1, 2022; review and consolidation of Service City ILA comments to be submitted to DART in January/February 2023,
2. Continue discussions, in January 2023, with DART to ensure that the City of Dallas' recommended uses of funds are in-line with DART's intended uses,
3. Brief and discuss the recommended uses of funds and project listings during the February 2023 Transportation and Infrastructure (TRNI) Committee meeting,
4. City Council briefing on March 1, 2023, to discuss the ILA and recommended programs and projects to be funded; City Council action for approval of programs and projects and ILA approval anticipated by March 2023.

LEGISLATIVE PROGRAM BRIEFING

North Central Texas Council of Governments (NCTCOG) staff updated the RTC on federal and state legislative efforts related to air quality and transportation issues affecting the Dallas-Fort Worth region.

DALLAS AWARDED “OUTSTANDING INITIATIVE” BY AIR NORTH TEXAS PARTNERS

NCTCOG’s Air North Texas Partners awarded the City of Dallas the “Outstanding Initiative” award for its leadership in programming/initiatives to improve air quality.

Some of the City’s many initiatives to improve air quality include the Community Air Monitoring program, the Comprehensive Environmental and Climate Action Plan (CECAP), Clean Air Action Day, Earth Day Every Day events, the North Texas Climate Symposium, Environmental Commission presentations on air quality, the Dallas Climate Action website, and the Green Dallas website.

SOUTHERN GATEWAY RIBBON CUTTING

A ribbon cutting ceremony was held on November 30, 2022 to commemorate the completion of the Texas Department of Transportation's (TxDOT) \$666 million Southern Gateway project.

To complete the project, TxDOT and its partners rebuilt and expanded a total of ten miles of roadway which widened both general purpose and non-tolled managed lanes along I-35E between U.S. 67 and Interstate 30 (I-30) and on U.S. 67 between Interstate 20 (I-20) and I-35E south of downtown Dallas. As part of TxDOT's Texas Clear Lanes initiative, the new improvements to the major highway system enhance safety and provide significant congestion relief for more than 180,000 motorists per day in southern Dallas County.





DART GoPASS TAP CARD PILOT PROGRAM EXTENDED

The Dallas Area Rapid Transit (DART) Board of Directors **extended the Discount GoPass Tap Card pilot program through December 31, 2024.**

The program provides riders using any one of nine support assistance programs with a **50% discount on the regular price of a DART local pass.**

DART launched the pilot-program to ensure riders who qualify have access to jobs, health care and educational opportunities, reducing social and economic inequalities by making mobility financially feasible to more people.

All new and current DART riders who participate in any of the following programs are eligible for DART services at half the fare:

- CHIP (Children's Health Insurance Program)
- TANF (Texas Temporary Assistance for Needy Families)
- CEAP (Comprehensive Energy Assistance Program)
- SNAP (Supplemental Nutrition Assistance Program)
- Housing Choice Vouchers
- DHA Housing Solutions for North Texas program
- Medicaid
- Medicare
- Texas WIC (Texas Special Supplemental Nutrition Program for Women, Infants, and Children)

Participants renewing their discount must visit the DARTmart store with documentation verifying participation in a qualifying program. **Current Discount GoPass® Tap card holders must renew their card registration by January 31, 2023, to keep their discount.**

DART RETURNED NINE MAJOR BUS ROUTES TO REGULAR FREQUENCY ON DECEMBER 12TH

On Monday, December 12, 2022, DART returned nine major bus routes to regular operating service frequency.

In June, to provide service dependability for riders, DART implemented a five-minute service frequency reduction on 31 bus routes due to a nationwide shortage of bus operators. Thanks to an aggressive hiring initiative by the agency, DART has returned nine of those bus routes to regular service.

At the January Dallas Regional Mobility Coalition (DRMC) meeting, Drew Campbell, Executive Director of the DRMC, provided a preview of what he expects to see during the State of Texas' 88th legislative session including the following data points/observations:

- The regular session runs from January 10th to May 29th
- Republicans control both chambers
- The session will have a lot of focus on excess revenues the State has generated.
 - It has been reported that Governor Abbott wants to use half of the surplus for property tax relief but that Lt. Governor Patrick wants to use the funds to shore up the state's electrical grid.
- Other issues likely to arise include:
 - Private school vouchers and additional school choice
 - Additional fixes for the state's power grid
 - More funding for border security, law enforcement, and school safety
 - Mandatory minimum sentences for people who use firearms in a crime
 - Revamping how state funding is determined for community colleges
 - Election security and integrity
 - Legalizing gaming
 - Expanding medical cannabis

102ND ANNUAL MEETING JANUARY 8TH THROUGH 12TH

The Transportation Research Board (TRB) is part of the National Academies of Sciences, Engineering, and Medicine and is the leading transportation innovation, research, and information exchange group serving the transportation sector.

The TRB provides leadership in transportation improvements and innovation through trusted, timely, impartial, and evidence-based information exchange, research, and advice regarding all modes of transportation.

DFW WELCOMES INAUGURAL SERVICE TO MELBOURNE, AUSTRALIA

Qantas Airways began non-stop service to Melbourne, Australia, on December 3, 2022.

This is DFW's longest route served at 8,992 miles and a flight time of 17 and a half hours. This is Qantas' second destination to Australia from DFW, complementing its daily service to Sydney.



2022 HOLIDAY TRAVEL STATISTICS

DFW Airport experienced one of its busiest holiday travel seasons.

4.18 million passengers travelled through DFW with a daily average of 209,000. This is up 1.1% compared to the same holiday travel period in 2019. December 30 was the peak travel day with over 250,000 passengers traveling through DFW and was the busiest day since the pandemic.

SERVICE MEMBERS SUPPORTED

Each December, local military units from Fort Sill in Lawton, OK, Sheppard Air Force Base in Wichita Falls, TX, and Goodfellow Air Force Base in San Angelo, TX, descend upon DFW to travel home and be with their loved ones for the Christmas and New Year holiday.



Although these service members are arriving when ticket counters, security checkpoints, and concessions are closed, the DFW Airport

community came together to open for four nights in support of the over 4,500 arriving members.
