Rules of Courtesy

- All persons should refrain from private conversation, eating, drinking and smoking while in the Council Chamber.
- Posters or placards must remain outside the Council Chamber.
- No cellular phones or audible beepers allowed in Council Chamber while City Council is in session.

"Citizens and other visitors attending City Council meetings shall observe the same rules of propriety, decorum and good conduct applicable to members of the City Council. Any person making personal, impertinent, profane or slanderous remarks or who becomes boisterous while addressing the City Council or while attending the City Council meeting shall be removed from the room if the sergeant-at-arms is so directed by the presiding officer, and the person shall be barred from further audience before the City Council during that session of the City Council. If the presiding officer fails to act, any member of the City Council may move to require enforcement of the rules, and the affirmative vote of a majority of the City Council shall require the presiding officer to act." Section 3.3(c) of the City Council Rules of Procedure.

Handgun Prohibition Notice for Meetings of Governmental Entities

Dallas Crime Plan

Primary Strategies

1. **Hot Spots Policing:** A near term strategy meant to substantially increase police visibility at micro-places (grids) where violent crime is concentrated; focus on repeat and high-risk violent offenders.
2. **Place Network Investigations:** A mid term strategy focused on networks of violent places; multi-disciplinary approach to addressing underlying conditions that give rise to violence.
3. **Focused Deterrence:** A longer-term strategy to help break the cycle of violence among the small number of repeat and high-risk offenders who are responsible for committing most of the violent crime in Dallas.

Crime Plan Implementation

The Dallas Crime Plan began in May 2021.

To date, **8 hot spot intervention periods** have been completed and **two PNI locations** have been identified and treated.

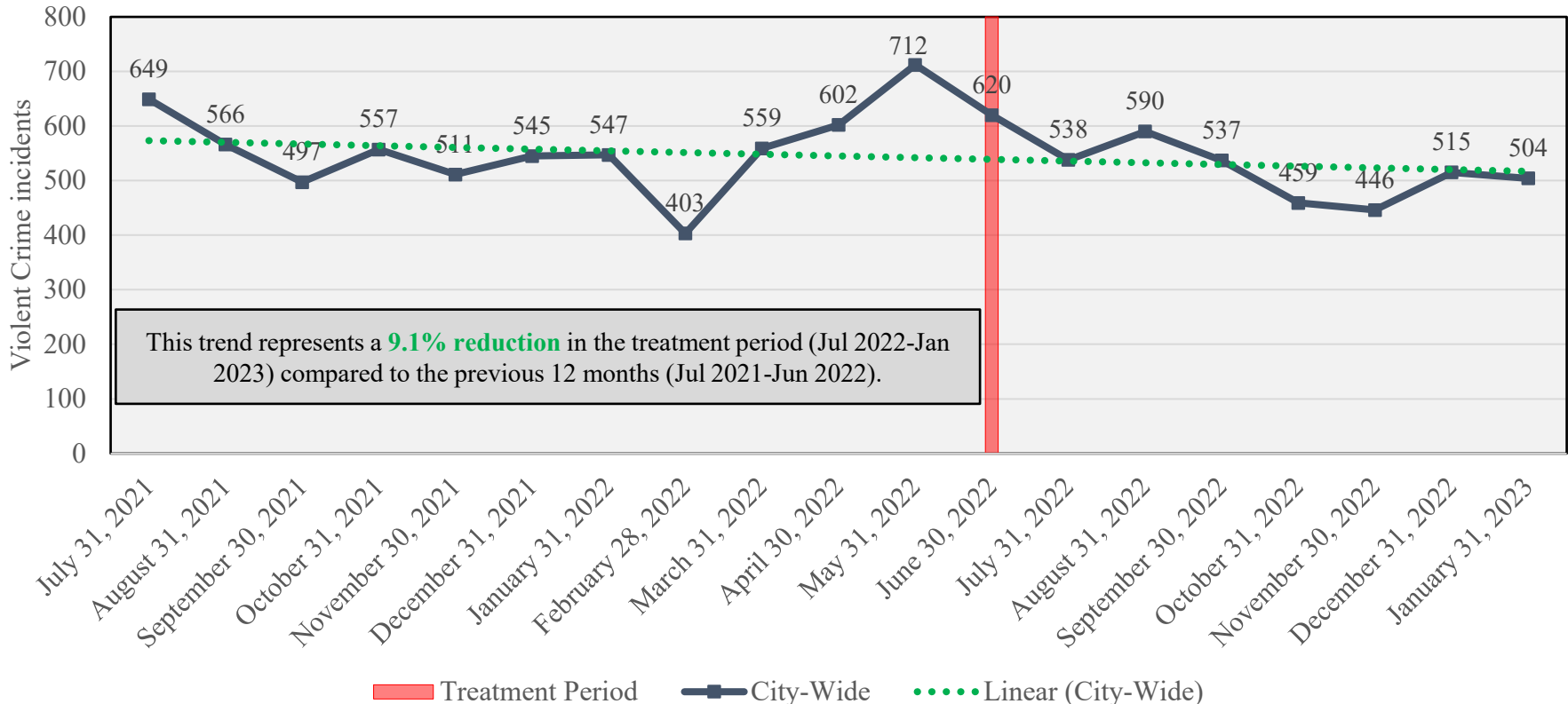
The focus of this update is on the **first half of Year 2** of the Dallas Crime Plan: **July 2022 through January 2023**

Treatment Methodology

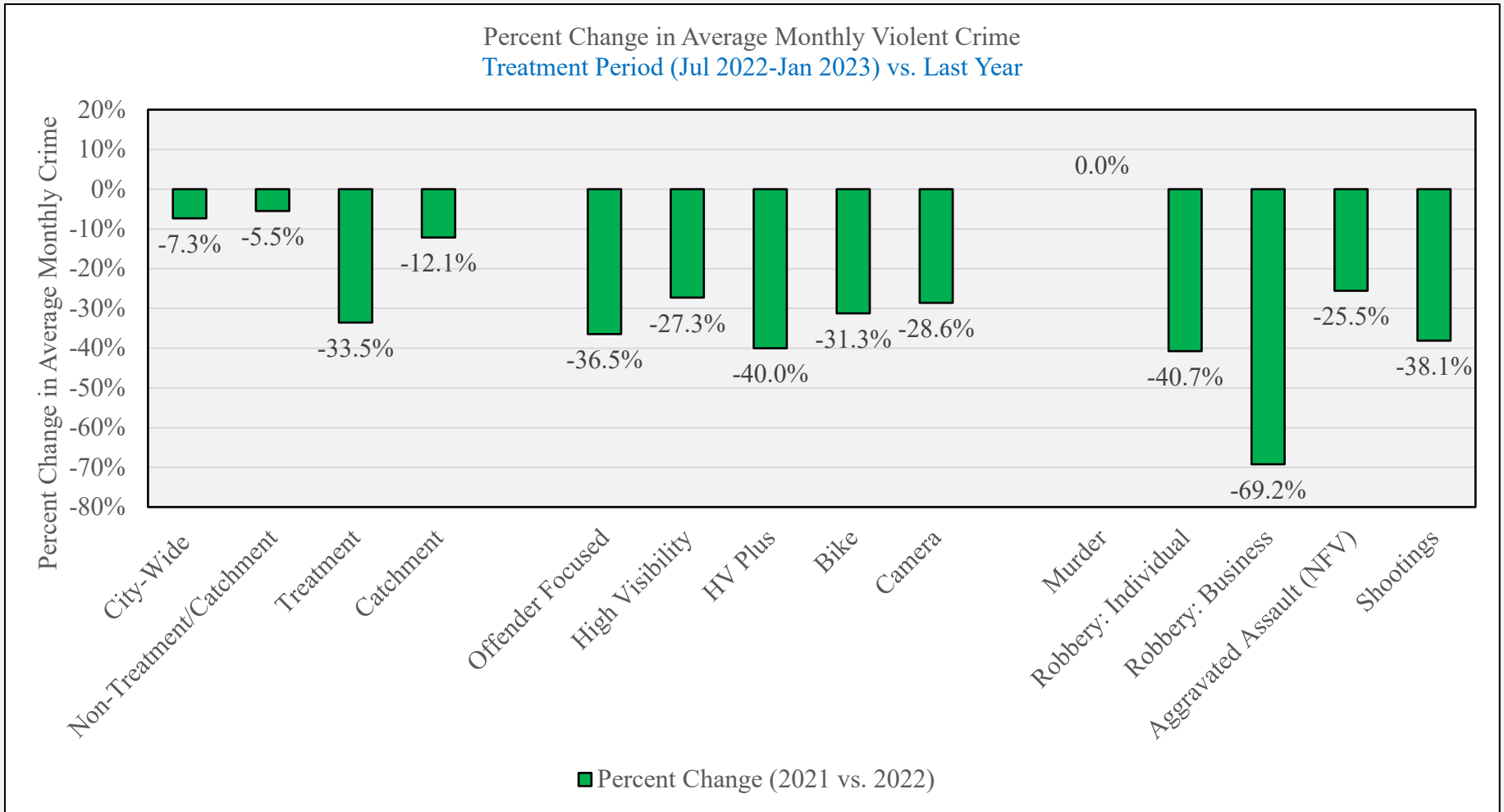
- Violent street crime analysis to identify hot spots in the previous 60 days and/or 12 months:
 - Murder/non-negligent manslaughter
 - Robbery (individual or business)
 - Aggravated assault (not including family violence)
- Unit of analysis is **violent incidents within grids**
- Two primary treatments
 - **High Visibility:** Officers sit stationary in lighted patrol cars for 15 minutes during peak crime hours/days of the week
 - **Offender-Focused:** Division-based Crime Response Teams focus on known and other high-risk violent offenders within targeted grids

Crime: Treatment Period v. Prior 12 months

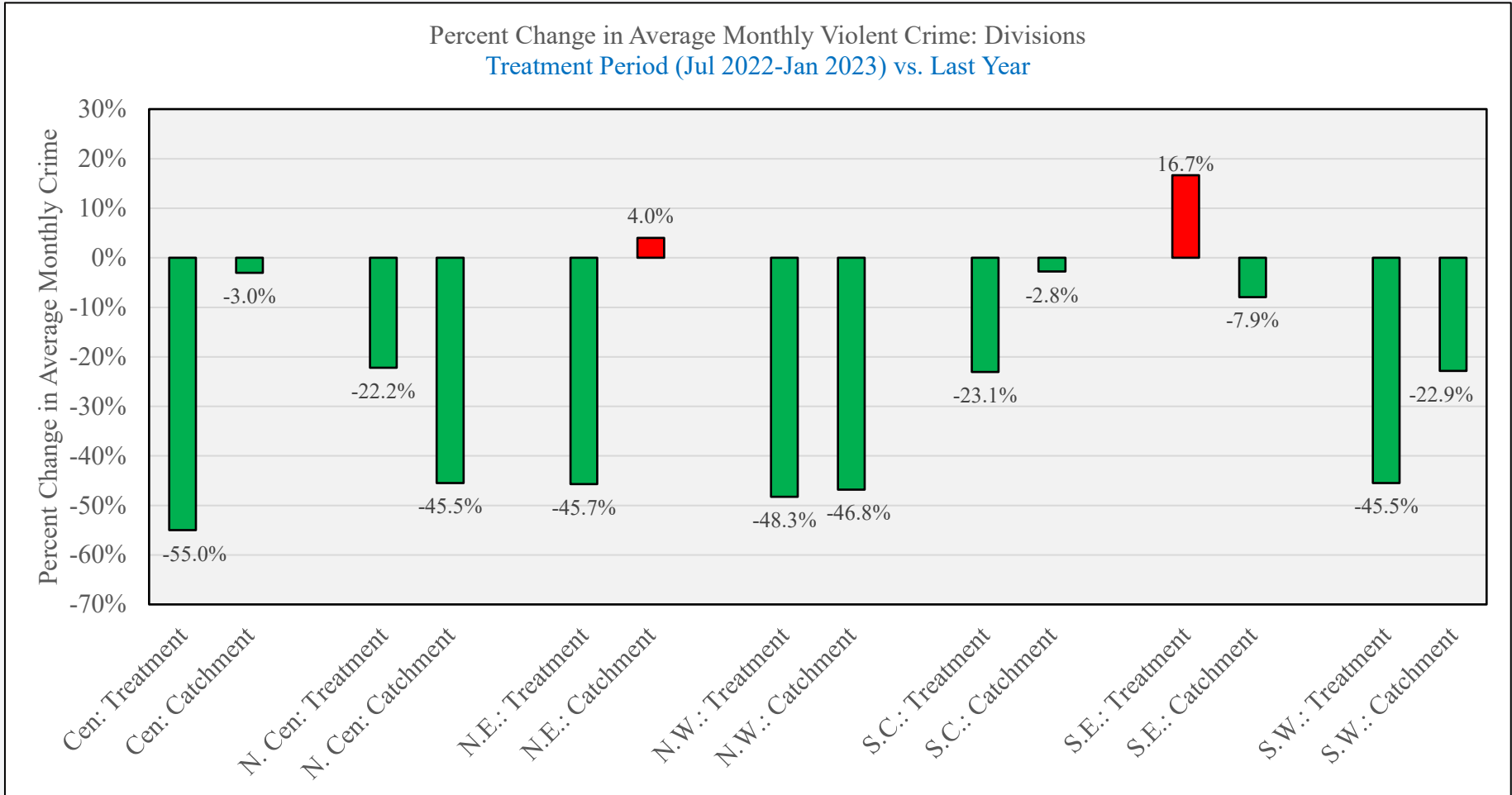

Crime: Treatment Period v. Last Year



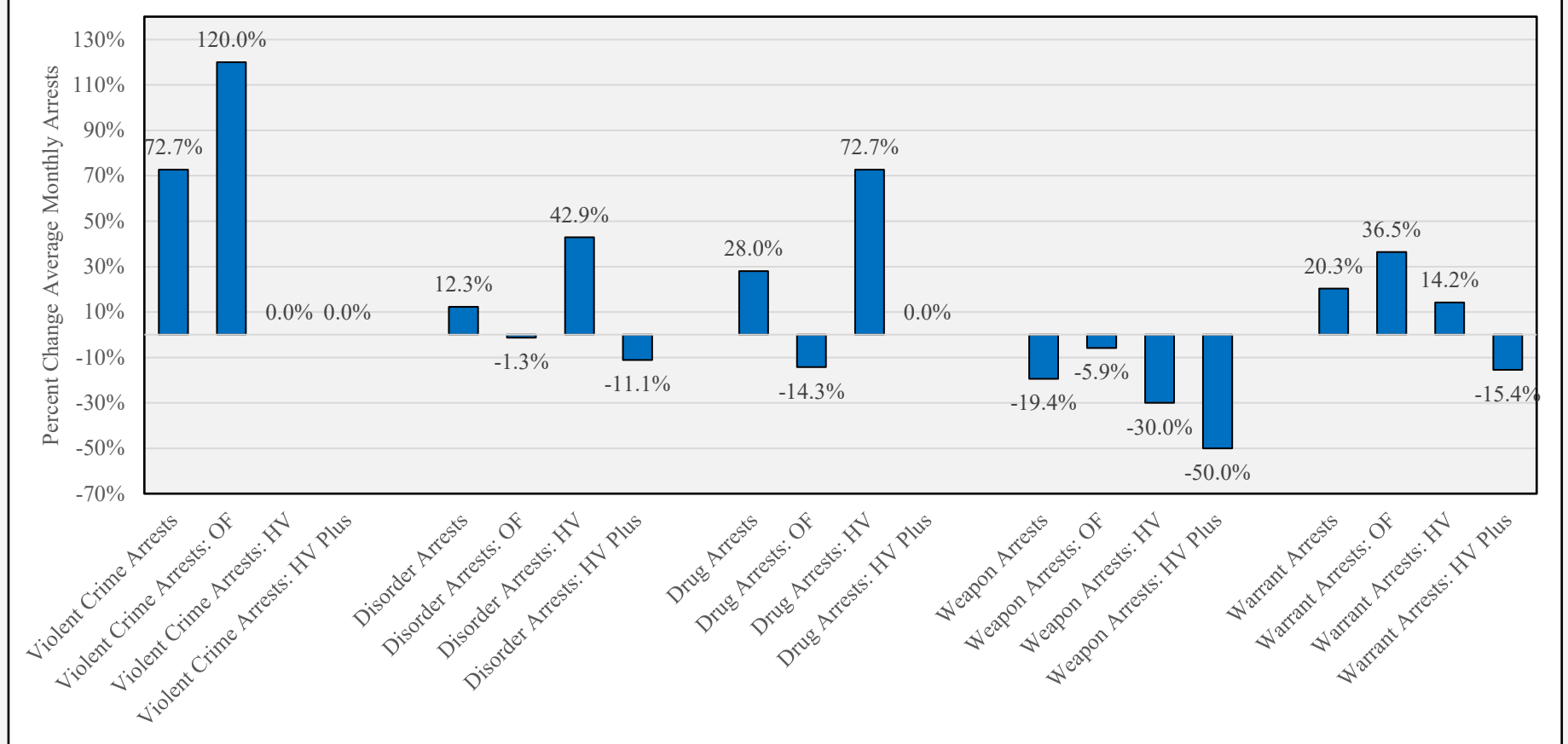
Crime: Treatment Period v. Last Year (Divs.)



Arrests in Grids: Treatment Period v. Last Year

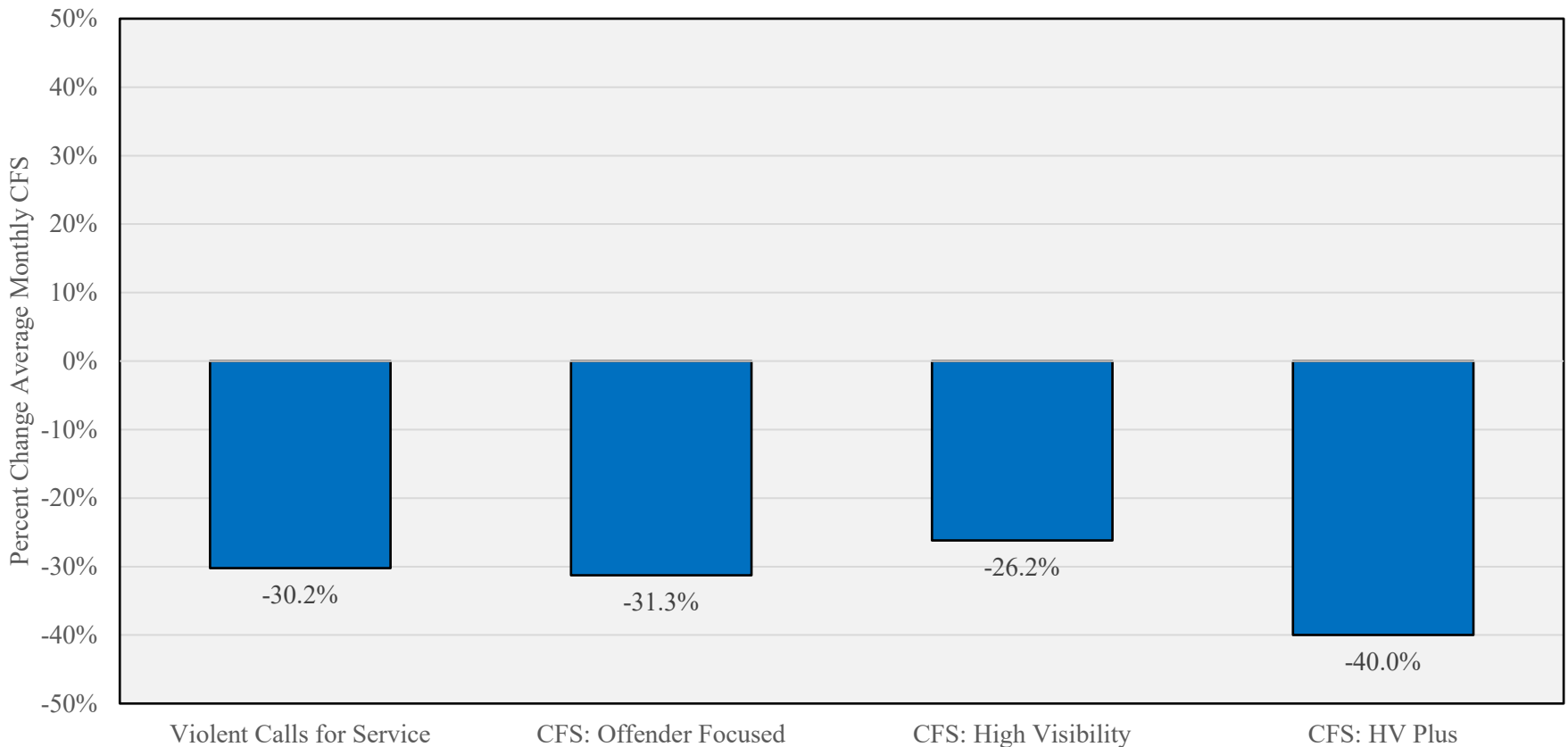
Comparison of Average Monthly Arrests (Treatment Grids ONLY)

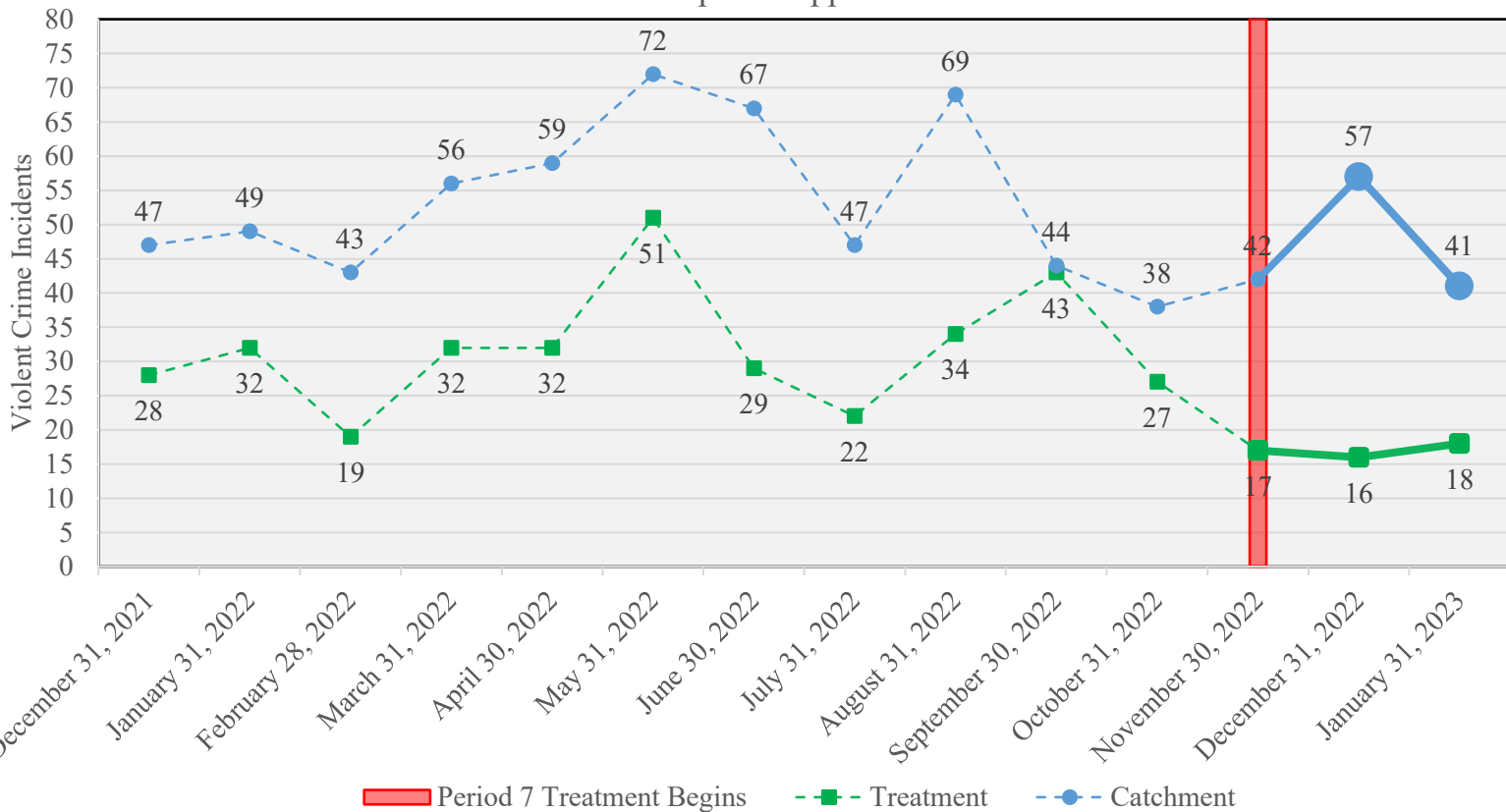

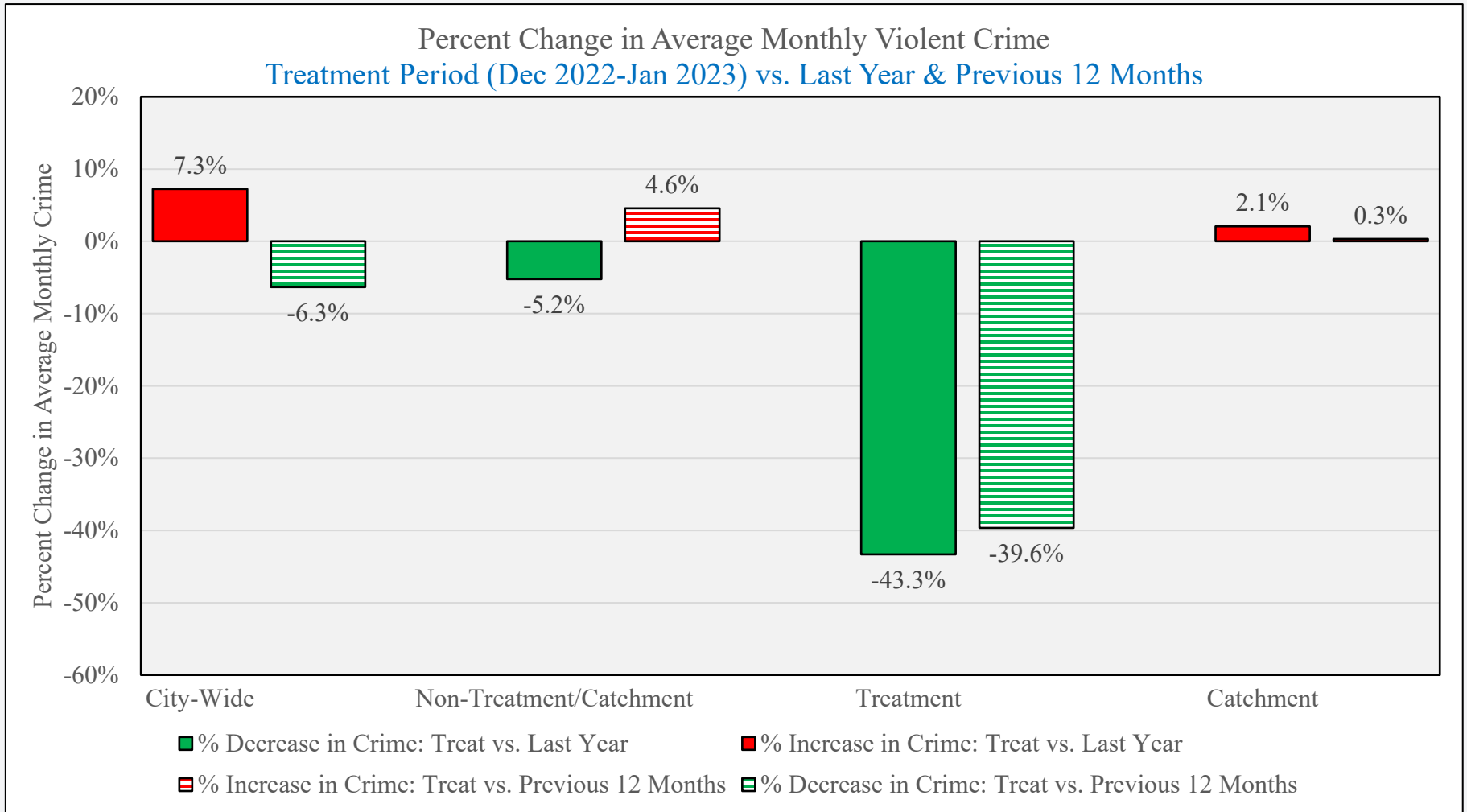

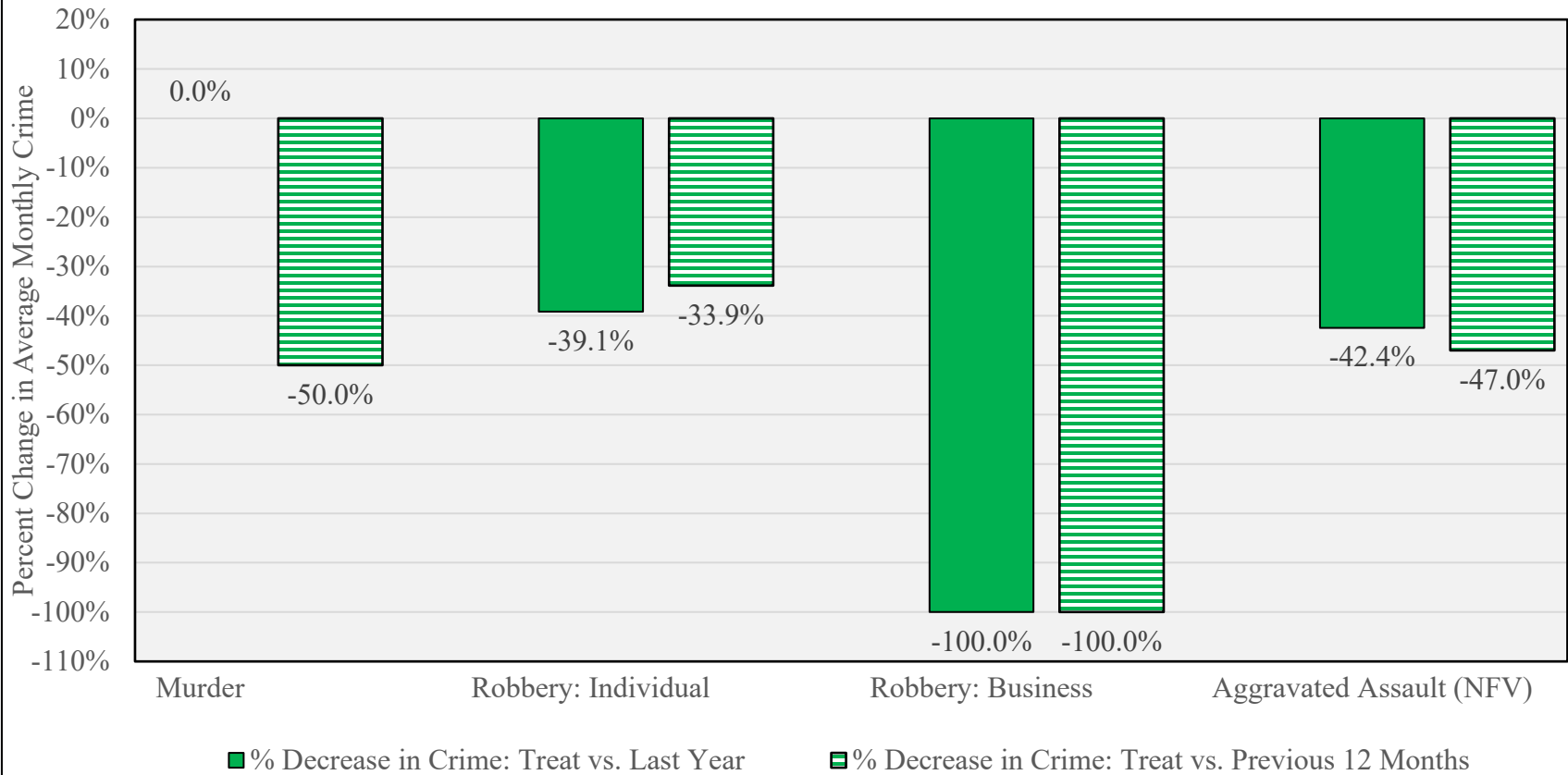

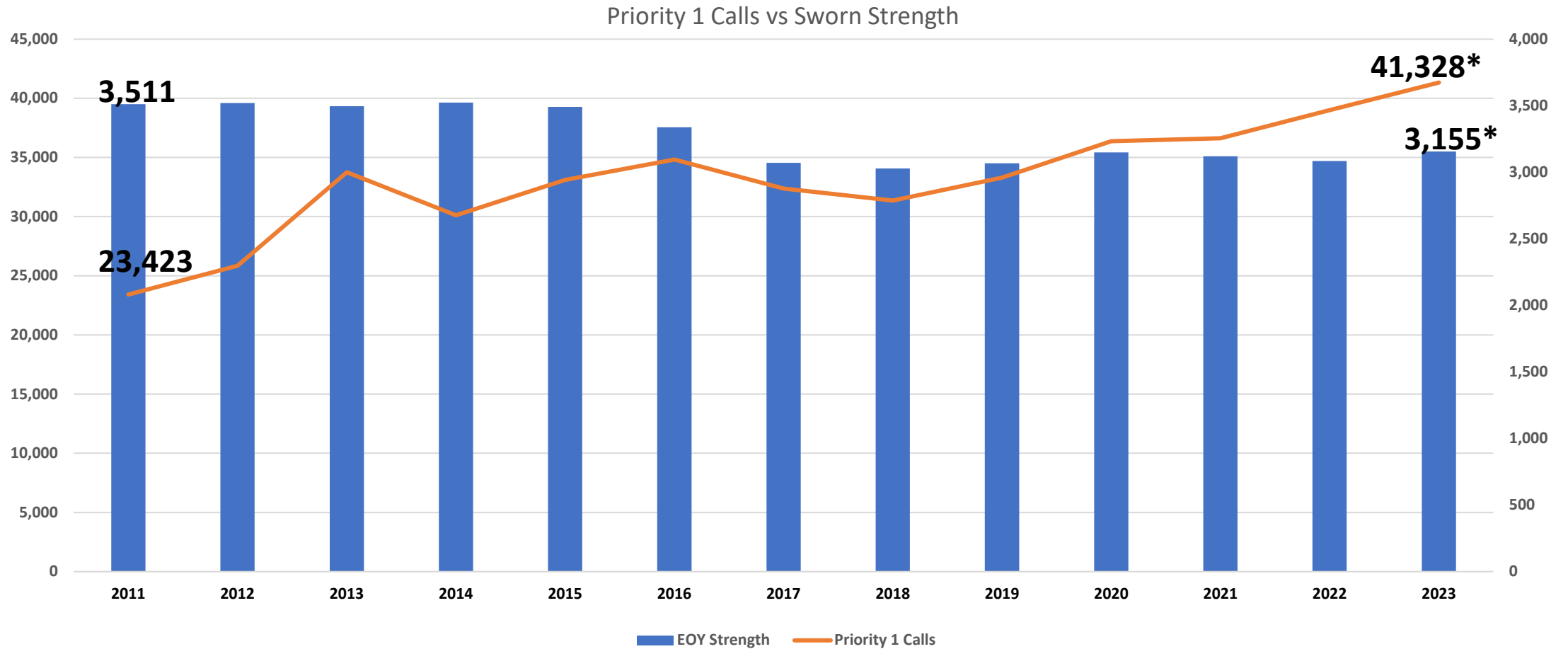

Please accept this memorandum as an update to the ongoing construction projects involving fire stations through a collaboration between Dallas Fire-Rescue (DFR) and the Office of Bond and Construction Management (BCM), Office of Economic Development (ECO), and construction contractors:

1. Station 19 (5600 E. Grand Ave) – The contractor has completed interior finish-out of Living Quarters and Apparatus bays. Final inspections, including testing of emergency generator, fire alarm, and fire suppression systems are currently underway. BCM anticipates completion this month.
2. Station 36 (2300 Singleton Blvd) – Completed. DFR began operations at this new facility on April 3, 2023.
3. Station 41 (5920 Royal Ln) – After the placement of the concrete slab foundation in late March, structural masonry wall construction is now underway for the Apparatus Room enclosure. Completion of this facility is expected in November 2023.
4. Station 58 (9393 Water Mill Rd) – Completed. DFR began operations at this new facility on May 1, 2023.

Dallas Fire-Rescue (DFR), in order to provide excellent service delivery to the residents of the City of Dallas, strives to maintain adequate resources to allow for efficient and effective emergency response. Please accept this memorandum as an update of the recent efforts to improve the overall maintenance of the DFR emergency fleet and operations.

The status of emergency apparatus, as of May 1, 2023, is as follows:

To address current shortages apparatus, DFR has developed and deployed various strategies. The utilization of rental agreements has provided additional resources. The Squad Program places personnel assigned to heavy apparatus (engines and trucks) which are out of service for repairs on light weight vehicles with a modified response plan to mitigate gaps in emergency response coverage. Special Event ambulances are being utilized to cover for front-line Rescues. In the very near future, a Medic Squad program will be launched, which will be similar in design to the Squad Program for heavy apparatus: Lightweight vehicles will be staffed by personnel assigned to Rescues out of service for repairs with modified response plans to mitigate gaps in emergency response coverage.

Additional programs launched by DFR include a more aggressive and comprehensive preventative maintenance plan for all apparatus, a stronger driver safety program, and the deployment of three grant-funded blocker vehicles to increase safety on incidents occurring on major thoroughfares.

Optimally, DFR strives to maintain not only a full fleet of front-line apparatus, but also a minimum 15% reserve fleet for each unit type. Unfortunately, DFR's Fleet Maintenance

Division has been severely challenged to meet this goal due to a myriad of obstacles including global supply chain issues for both repair parts and replacement units, motor vehicle collisions involving apparatus, and maintenance staffing vacancies.

Currently, DFR and its contract repair partners continue to work diligently to complete outstanding repair projects. DFR has 13 fire engines, 5 fire trucks, and 10 rescues that are currently out for long-term repairs.

DFR has placed orders for and is awaiting delivery of replacement units for all types of front-line apparatus. These orders have various delivery dates beginning in June, and include a total of 17 fire engines, 4 fire trucks, and 46 Rescues.

To address staffing concerns, DFR has strengthened its mechanic technician recruitment and retention through expanded recruitment sources and partnerships, improved salary scales, improved training, and a robust succession plan.

DFR anticipates that through the above plans and programs, this temporary fleet shortage will soon be over. It is our expectation that the resulting improved operational, training, and staffing plans will aid in further protecting the status of our emergency fleet for years to come.

Dallas Fire-Rescue (DFR) is nearing completion of the Texas Best Practices Recognition program for Texas fire departments. We have spent several years on this program, which is comprised of three phases: The first phase is a guided self-assessment, the second phase involved rectifying identified areas for improvement, and the third phase is a full review by an independent team from the Texas Fire Chiefs Association. This phase was initiated this year and the team is currently conducting their review and submitting recommended revisions of our practices.

One such revision was the adoption of the 2021 International Fire Code, which was recently accomplished. Our Texas Best Practices Team will continue to work with the Review Team to implement any additional revisions. We anticipate completion of this process by the end of FY23.

Recognition under this program signifies that a fire department is following best practices for the State of Texas. Upon completion, DFR will be the largest department that has achieved this esteemed status.

SUBJECT **Court & Detention Services Management Software Upgrade**

Court and Detention Services (CTS) is partnering with ITS and Tyler Technologies to upgrade the current Court Case Management System (CCMS), formerly known as INCODE 9 and replace it with Municipal Justice (MJ) 9.01. In preparing for the upgrade, ITS has replaced the end-of-life servers, and this upgrade will provide a more user-friendly system for staff and provide an improved level of customer service to our face-to-face customers.

While these dates are tentative, the current CCMS is scheduled to be out of service starting May 12, 2023, at 8 pm. Once the upgrade is completed on May 20, 2023, at 6 am, the system will Go Live. During the install, the Court building will be closed to the public and will not be able to assist customers due to a lack of access to the CCMS. However, Live Chat will remain operational to provide general citation information, but not anything case specific. In addition, the City Detention Center will only accept arrests for limited Class C offenses and Class C arrest warrants from agencies outside of Dallas.

During the installation, Tyler Technologies will be on-site at all locations to provide refresher training to staff on the new features and functionality of the MJ upgrade. Tyler's on-site staff will work with the Municipal Court and ITS to ensure a seamless transition. During this shutdown, the Municipal Court will take every opportunity to meet any outstanding City training requirements. Ultimately, this upgrade will provide much-improved functionality and operational effectiveness of the Court Case Management System. Authorize the purchase of automated chest compression systems for the Fire-Rescue Department with Stryker EMS through the National Association of State Procurement Officials cooperative agreement - Not to exceed \$344,455.02 - Financing: Coronavirus State and Local Fiscal Recovery Funds

BACKGROUND

The purchase of automated chest compression systems will provide high-quality and consistent chest compressions in emergency situations including patient movement, transportation, and during prolonged CPR. This automated CPR device will be used to perform life-saving chest compressions during transport of patients while Fire-Rescue Department personnel remain safely seated. These systems are carried on all dispatched Emergency Medical Service Field Supervisor vehicles driven by Command Staff. This device reduces fatigue in personnel by eliminating prolonged resuscitation attempts and switching personnel.

The National Association of State Procurement Officials cooperative agreement is authorized by Chapter 791 of the Texas Government Code and Subchapter F, Chapter 271, Texas Local Government Code. Section 271.102 of the Texas Local Government Code which authorizes a local government to participate in a Cooperative Purchasing Program with another local government or a local cooperative organization.

PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On June 23, 2021, the City Council authorized the acceptance of grant funds from the U.S. Department of Treasury for the Coronavirus Local Fiscal Recovery Fund to provide relief during the ongoing COVID-19 pandemic by Resolution No. 21-1149.

On September 22, 2021, the City Council authorized the final reading and adoption of the appropriation ordinance for the FY 2021-22 City of Dallas Operating, Capital, and Grant & Trust Budgets, which included the ARPA funds from the U.S. Department of Treasury for the Coronavirus Local Fiscal Recovery Funds by Resolution No. 21-1590.
