#### **Rules of Courtesy**

City Council meetings bring together citizens of many varied interests and ideas. To insure fairness and orderly meetings, the Council has adopted rules of courtesy which apply to all members of the Council, administrative staff, news media, citizens and visitors. These procedures provide:

- That no one shall delay or interrupt the proceedings, or refuse to obey the orders of the presiding officer.
- All persons should refrain from private conversation, eating, drinking and smoking while in the Council Chamber.
- Posters or placards must remain outside the Council Chamber.
- No cellular phones or audible beepers allowed in Council Chamber while City Council is in session.

"Citizens and other visitors attending City Council meetings shall observe the same rules of propriety, decorum and good conduct applicable to members of the City Council. Any person making personal, impertinent, profane or slanderous remarks or who becomes boisterous while addressing the City Council or while attending the City Council meeting shall be removed from the room if the sergeant-at-arms is so directed by the presiding officer, and the person shall be barred from further audience before the City Council during that session of the City Council. If the presiding officer fails to act, any member of the City Council may move to require enforcement of the rules, and the affirmative vote of a majority of the City Council shall require the presiding officer to act." Section 3.3(c) of the City Council Rules of Procedure.

# Handgun Prohibition Notice for Meetings of Governmental Entities

# VCPU Operations Summary



### PNI/PSN Activity for May of 2023

- (87) Investigative Mark-outs






# VCPU Operations — PSN, Homicide, CRT



- On May 11, 2023, a shooting occurred at **9750 Forest Lane (PSN location and adjacent to GRID)** in which two suspects fired rifle(s) injuring two complainants who were standing on a third-floor balcony. Patrol officers responded & provided good actionable intelligence regarding one of the suspect's vehicles.
- Shortly thereafter, PSN located one of the suspect vehicles and followed it to an address in Dallas. Soon after, PSN located a second suspect vehicle at the same address.
- Northeast CRT and Deployment units responded to conduct an investigation.
   When attempting to leave in their vehicles, suspects were detained on traffic stops.
- A lawful search of both suspect vehicles resulted in the recovery of a handgun, and the arrest of a suspect for two unrelated Aggravated Assault Warrants in 2022.
- PSN officers obtained verbal and written consent to search the Dallas residence, and subsequently (3) additional handguns and (2) long barrel rifles were discovered, along with clothing that matched video surveillance from the offense.
- Suspects were interviewed and charged with several counts of Aggravated Assault.





## **VCPU Operations – PNI Warrant**



- In May, PNI task force officers received drug complaints related to (2) residences at **3535 Webb Chapel Extension** (PNI location).
- PNI Intelligence revealed one of the residences was operated by a known individual who has a history of drug distribution in the Northwest PNI area.
- PNI officers conducted various relentless follow-up techniques which resulted in the obtainment of a search warrant for both residences.
- On May 11, 2023, the Dallas Police SWAT Unit simultaneously executed the two search warrants. Assisting the PNI Taskforce during the warrant execution were the PNI Bike Squad, PSN Unit, Northwest CRT, and HSI agents/TFOs.
- As a result, (5) suspects were placed under arrest for various felony offenses, including the known drug offender.
- Seized property included \$44,267 in currency, (2) handguns with one determined to be stolen, and other evidentiary items related to the sale and distribution of narcotics.
- Seized Narcotics included 6.5 grams of Cocaine, 69.5 grams of Methamphetamines, 208.0 grams of Heroin, and 4.8 grams of Alprazolam.





# VCPU Operations — PSN, Homicide, CRT



- On May 15, 2023, a shooting occurred at 9501
   Forest Lane (PSN location and adjacent to
   GRID) where a complainant was pronounced deceased.
- Through various relentless follow-up techniques, PSN officers located a suspect vehicle.
- Working with homicide, PSN and Northeast CRT located and attempted to perform a traffic stop of the suspect vehicle.
- Suspect fled on foot with a backpack and threw down a handgun underneath his vehicle. He was quickly apprehended.
- Recovered handgun was determined to be the weapon used in the homicide. Mask used in homicide also recovered.
- Suspect was charged with Evading and Capital Murder.





# VCPU Operations – PNI Warrant



- In April, PNI Detectives received intelligence from an NPO Officer assigned to the Red Bird Outreach Center regarding the sale of narcotics at 7676 S. Westmoreland Road (GRID location).
- PNI officers conducted various relentless followup techniques which resulted in the obtainment of a search warrant for the residence.
- On May 16, 2023, the Dallas Police SWAT Unit executed a search warrant at the residence. Assisting the PNI Taskforce during the warrant execution was the PNI Bike Squad, Southwest CRT and Patrol, and the Red Bird Outreach Center.
- Upon warrant execution at this location, (2) suspects were arrested for Unlawful Possession of a Firearm by Felon and Manufacture and Delivery of a Controlled Substance.






# VCPU Operations – PSN Homicide Arrest



- On March 27<sup>th</sup>, PSN officers were conducting surveillance related to an aggravated robbery investigation at 10304 Forest Lane (PSN location). An officer observed a suspect fire a rifle into a vehicle striking a male complainant in the shoulder and immediately flee in a vehicle.
- PSN officers followed the shooter to a residence and PSN and Northeast Patrol units surrounded the residence. The shooter and another suspect (fugitive from Mississippi) subsequently surrendered without incident.
- After obtainment of a search warrant, the rifle was used in the offense was recovered from the suspect vehicle.
- The shooter was arrested in connected to the previous aggravated robbery investigation, and he was further charged with Aggravated Assault and Deadly Conduct in relation to the shooting.
- On May 31st, Homicide detectives charged the shooter for **Capital Murder** in relation to a double homicide which occurred at the Bitter End Bar on March 15, 2023. Through a North Texas Crime Stoppers tip and various relentless investigative techniques, detectives obtained probable cause and substantiated the shooter's involvement in the Deep Ellum homicides.









# VCPU Operations – Aggravated Assault



- On May 20, 2023, PNI Detectives were called out on a shooting call at 3535 Webb Chapel Extension (PNI location).
- It was discovered a suspect fired several rounds into an apartment complex striking a Latin male several times.
- After conducting an investigation, Assault detectives identified the suspect and (2) Aggravated Assault warrants were issued for him.
- Later, PNI detectives and the Dallas Fugitive Unit determined the suspect had traveled to a location in Mississippi and informed a local Sheriff's Department.
- On May 31, 2023, the suspect was apprehended in Mississippi in relation to the shooting offense.
- The suspect has 15 previous offenses consisting mainly of manufacturing & delivery of drug offenses.






### VCPU Operations – "Department Store Crew" Arrest



- In 2022 and 2023, unknown suspects committed at least (19) robbery/theft offenses across the City in which they threatened and assaulted a major department store's employees to obtain high value secured electronic merchandise.
- On May 20, 2023, three suspects operating a vehicle used in a previous offense entered (2) department stores in Dallas and took approximately \$2,000 worth of electronics by threat of force. A description of the suspects were obtained by officers.
- A short time later, **Northwest CRT officers** located the suspect vehicle in Dallas and observed suspects wearing the same clothing as described. Officers observed two suspects offloading electronics, and subsequently put on masks, gloves, and each place a handgun in their vehicle.
- When Northwest officers attempted a traffic stop, the suspects evaded in their vehicle with two children (3 and 4 yr olds), but they were quickly apprehended.
- The (2) suspects received various charges including Felony Theft, Evading in a Vehicle, Endangering a Child, and Unlawful Possession of Firearm by Felon.
- The stolen property was recovered, and (4) *four firearms* were seized from the suspects.





# VCPU Operations - Serial Robbery Arrests



- In May, a series (8) of individual and business robberies occurred in Sector 540 of the Northwest Division. The offenses spanned shoplifts involving force to carjackings & robberies at gunpoint. Based on gathered intelligence, suspects appeared to be the same.
- The Robbery Unit, assisted by Northwest Patrol, spent extensive time in follow-up investigative techniques to identify several of the suspects.
- After obtaining probable cause, Robbery detectives issued several warrants for multiple suspects.
- On May 31<sup>st</sup>, the Fugitive Unit executed the warrants simultaneously at multiple locations in Dallas. (2) Adult and (4) juveniles were arrested in relation of the Aggravated Robberies.
- During the warrant executions, (2) handguns, (1) rifle, and several large capacity magazines (including a 100 round capacity magazine) were seized.







  - Begins with a problem-focused investigation designed to uncover, identify, and disrupt the criminal networks that contribute to the violent crime in Dallas.
  - There are currently (3) PNI Locations:
    - 11760 Ferguson Rd and 3535 Webb Chapel Currently holding periodic meetings with DPD specialized units and other City departments to combat the crime and address blight issues according to the operational plan. PNI Task force and CRT Units actively conducting investigations at or related to these locations.
    - **3550 E. Overton Rd** Conducting follow-up according to maintenance plan to continue to abate crime and blight issues.
- Focused Deterrence
  - Currently scheduled to hold first call-in session on June 12th, which had been made possible through extensive collaboration and assistance by Probation, TDCJ Parole, the District Attorney's Office, and our community partners and non-profit organizations.

## Reactive vs Proactive strategies



#### Reactive

- Random Patrols
- Rapid Response to 911 calls
- Investigation of reported crimes

#### Proactive

- Systematic and Data driven
- Parallels tied to Department's Violent Crime Plan
  - Placed Based approach:
    - Directed patrols and targeted resources used in areas known historically for RGF
  - Person focused approach:
    - Identifying those individuals wanted for gun crimes
    - Gang identification and location awareness
      - Monitoring of Social Media and other underground sites to monitor social gatherings and subjects on parole/probation for gun offenses



# **Proactive strategies**



#### Enhanced Prosecution:

- All patrol divisions now have a designated gun detective
  - First piloted in the SW Patrol Division in October 2022
  - Tasked with filing offenses of UPF, UCW, and Discharging Firearm in Certain Municipalities
  - Can be stand alone charges or filed with the primary offense i.e.. Aggravated Assault, Deadly Conduct
  - Provides Division Commanders an avenue to address gun related crimes where the primary offense may have been suspended
  - All gun detectives will be Task Force Officers with the ATF
    - Access to ATF resources and enhanced federal prosecution of gun cases

#### Federal partnership:

- Weekly Gun CompStat briefings to discuss gun related incidents/offenses Conducted with DPD leadership and members of the ATF
- Data driven information specific to locations, suspect vehicles, weapons, National Integrated Ballistic Information Network (NIBIN) leads, known suspects, ongoing operations
- Assist Department in Federal prosecution of gun related crimes



## Proactive strategies



#### Community Engagement

- Utilizing NPOs to engage with members of the community on known locations of RGF
- Distribution of flyers/door hangers in areas identified as having higher incidents of RGF
- Collaborate with the Office of Integrated Public Safety Solutions to assist in mitigating factors that contribute to RGF and crime in neighborhoods
- Focused deterrence placing a focus on select group of individuals that have been involved in gun related crimes.
  - Strong message from Department that gun crimes will not be tolerated
  - Additional support and outreach to high-risk offenders

#### License Plate Recognition

- Strategic deployment in areas associated with RGF and violence
- Assist officers locating vehicles involved in RGF and identification of possible suspects

#### Drones

- Recently assisted in an operation conducted in the Northeast Patrol Division which led to several arrests
  of subjects participating in RGF

#### Shot Detection systems

- "Book is still out"



### **Purpose**



 Public Safety Committee Chair requested a two-year review of significant programs, topics, and policy issues that have been reviewed and addressed by the Committee.



### **Presentation Overview**



- Programs and policy discussion since 2021 have been grouped into the following categories:
  - Crime Reduction
  - Services and Programs
  - Transparency and Accountability
  - Training
  - First Responder Wellness



### **Crime Reduction**



- Violent Crime Reduction Plan A comprehensive strategy to reduce violent crime.
- Domestic Violence Crime Reduction Plan A plan to target/reduce domestic violence.
- Violence Interruption Credible messengers targeting violence reduction in high crime areas.
- Street Racing Task Force Provide targeted enforcement and response to street takeover events.
- Habitual Nuisance Property Designation Allows Code to designate a property as Nuisance Property.







### **Crime Reduction**



- C-Store Ordinance Enforcement Allows for Code to serve as the primary enforcement department to provide more coordinated inspections of Convenient Store to reduce the burden on DPD.
- Juvenile Curfew Ordinance Renewed the juvenile curfew for another 3 years.
- Sexually Oriented Business (SOB) Established 21 as the minimum age for employment and to deter violent criminal activity focused on revising the closing time of SOB establishments.



### **Crime Reduction**



- Commercial Promotors Ordinance To ensure protection for attendees and the public and to reduce the unreasonable use of public safety resources.
- **Multifamily Inspection Team** Assist apartment communities to improve quality of life and safety using a collaborative process.
- Crime Prevention Through Environmental Design (CEPTED) To include mandatory CEPTED standards for multifamily properties designated as a habitual criminal and/or nuisance property that fall within high-risk crime area as defined through Risk Terrain Modeling.



### **Services and Programs**

- Mobile Crisis Response Teams Support residents with direct service navigation for behavioral health and other social services.
- Sobering Center Provides services to individuals arrested for public intoxication. Individuals participating in the program can avoid additional criminal charges.
- EMS Quality Management Program To ensure the quality, efficiency, and effectiveness of EMS services.
- Single Function Paramedic Program To improve response times by dedicating single purpose paramedics to peak EMS call zones and times.
- Towing Management Program To reduce the amount of time officers wait on tow trucks and return to service quicker and establish two new alternate storage sites for impounded vehicles.







### **Services and Programs**



- Emergency Shelter Standard Operation Procedures To provide direct assistance up to 72 hours for incidents impacting less than 25 families, and congregate sheltering for incidents impacting more than 25 families.
- Lew Sterrett Jail Contract A contract with the County that resulted in a more transparent methodology for calculating the City's expenses at Lew Sterrett.
- Conditional Dismissal Program Pilot To offer conditional dismissal for certain first-time offenders to prevent conviction and subsequent criminal record.
- Overdose Response Team Partnership between Recovery Resource Council and Dallas Fire & Rescue Department to conduct follow up visits with clients who are struggling with substance use and have recently experienced an overdose requiring transport to a hospital or 911 call.



### Transparency and Accountability



- **DPD Early Warning System** Benchmark Analytics program to assess officer behavior and activity to determine if early interventions are warranted.
- DPD & DFR Interactive Dashboards Online interactive call and response activity for police and fire.
- **DPD Domestic Violence Dashboard** Online interactive dashboard to report DPD investigations, District Attorney cases and shelter provider metrics.
- **Use-of-Force Reporting Platform** To determine the reasonableness and appropriateness on an officer's use of force. The program includes a public dashboard that can be used to identify trends and patterns, evaluate risk and detect potential problems.



### **Training**



- Active Bystandership for Law Enforcement (ABLE) Provides active bystandership strategies and tactics for officers to prevent misconduct, reduce mistakes, and promote health and wellness.
- **Paramedic Training** Training for 133 firefighters to attend paramedic school helping to significantly increase the number of licensed paramedics in DFR.
- Dallas Police Academy MOU with UNT Dallas Memorandum of Understanding (MOU) to partner on the creation of new DPD police academy on the UNT campus.
- Anti-Hate Programs and Education Training for officers and creation of an internal Hate Crime Investigation and Analysis Committee.



### First Responder Wellness



- DPD Officer Mental Wellness Unit Help officers cope with stresses of their job, DPD created a unit dedicated to providing education and support resources, including counseling services.
- DFR Cares Program To help members access resources such as: Psychological Services, Resiliency, PEER Support, and Chaplaincy Services.
- Mental Health Leave Leave up to 40 hours for officers and up to 60 hours for firefighters who experience a traumatic event while at work and the need for the leave can be verified by a licensed psychiatrist or psychologist.

The following agenda item is scheduled to go before the City Council on June 14, 2023.

#### **AGENDA ITEM #42: 23-1423**

Authorize a five-year service price agreement for polygraph testing and examination services for the Police Department – Ruiz Protective Service, Inc., only bidder – Estimated amount of \$743,860 – Financing: General Fund (subject to annual appropriations)

#### **BACKGROUND**

This action does not encumber funds; the purpose of a service price agreement is to establish firm pricing for services, for a specific term, which are ordered on an as needed basis according to annual budgetary appropriations. The estimated amount is intended as guidance rather than a cap on spending under the agreement, so that actual need combined with the amount budgeted will determine the amount spent under this agreement.

This service price agreement will provide for polygraph testing and examination services for all police sworn and selected civilian applicants. All applicants applying for police officer positions are required to have a polygraph examination as part of the personnel screening process. The pre-employment polygraph examination is an essential tool utilized by police administrators as part of the selection process of possible candidates.

As part of the solicitation process and in an effort to increase competition, the Office of Procurement Services used its procurement system to send out email notifications to vendors registered under relevant commodity codes. To further increase competition, the Office of Procurement Services uses historical solicitation information, the Internet, and vendor contact information obtained from user departments to contact additional vendors.

On November 10, 2015, the City Council authorized a living wage policy that requires contractors to pay their employees a "living wage" rate as established annually by the Massachusetts Institute of Technology Living Wage Calculator for Dallas County by Resolution No. 15-2141. The current calculated living wage during the solicitation process of this contract is \$17.82; the selected vendor meets this requirement.

The following agenda item is scheduled to go before the City Council on June 28, 2023.

#### **DRAFT AGENDA ITEM 23-1586**

Authorize a three-year Cooperative Purchasing Agreement for the procurement of youth summer enrichment programming with Youth Guidance Inc. through the Dallas Independent School District (DISD) – Not to exceed \$1,200,000 – Financing: General Fund

#### **BACKGROUND**

Youth Guidance operates the Becoming A Man (BAM) and Working On Womanhood (WOW) social- emotional learning programs that foster agency, integrated identity, and social cognitive skill- building for targeted students in grades 7-12 who have been exposed to traumatic stressors and face social, behavioral, cognitive, or emotional challenges.

In response to the need for more programming that keeps youth positively engaged during the summer, Youth Guidance Dallas will implement the BAM and WOW Scholar Training Academy (STA). This Academy is a six-week, summer enrichment initiative that equips participants with knowledge, skills, and tools that will support their academic, professional, and personal growth and success. The STA will target youth impacted by violent crime and also prevent violent crime incidence by engaging youth in safe and skills-oriented programming.

The program runs Monday through Friday, 9:00 AM to 3:00 PM during which participants are guided through interactive lessons facilitated by BAM and WOW youth specialists, staff, and partnering organizations. Youth Guidance Dallas will partner with the City of Dallas to hold programming in local recreation centers in the communities closest to the schools served by the program.

Participants have access to curriculum-based group sessions as well as individual support services and curricula-aligned field trips and events. The curricula are grounded in a set of core program values that guide participants in learning, practicing, and internalizing key social-emotional skills.

#### PRIOR ACTION/REVIEW (COUNCIL, BOARDS, COMMISSIONS)

On February 13, 2023, the Public Safety Committee was briefed on Community Violence Intervention programming expansion which included this service.

The following agenda item is scheduled to go before the City Council on June 28, 2023.

#### **DRAFT AGENDA ITEM 23-1496**

Authorize a three-year service agreement with State Fair of Texas for the City of Dallas through its Dallas Fire Rescue Department to provide emergency medical services during (1) the fair at Fair Park every Fall in 2023 to 2025 on specified dates; (2) July Events and additional Events to be charged separately per the agreed rates; and (3) the receipt and deposit of the revenue funds - Estimated Revenue: General Fund \$590,025.00

#### **BACKGROUND**

For the last 135 years the State Fair of Texas (SFT) has been part of the City of Dallas history providing fair experience at the Fair Park every Fall to hundreds and thousands of visitors. That tradition has now grown and draws over two million visitors every year.

Among the services provided to the visitors has been the non-emergency medical transport services through a private contractor. For the next three years from 2023 to 2025, SFT requests an agreement with the City of Dallas through its Dallas Fire-Rescue Department (DFR) to provide the emergency medical services during the fair, July, and additional special events.

DFR provides the emergency medical services annually at the Fair from a dispatch 911 calls and transports to the area hospitals. This agreement will allow DFR to utilize special events rescues (Ambulances) to be deployed at the fair grounds and related covered events. The use of special events rescues will alleviate the use of the dispatched front-line rescue which in turn will be available to provide services during other dispatched medical calls.
