Rules of Courtesy

City Council meetings bring together citizens of many varied interests and ideas. To insure fairness and orderly meetings, the Council has adopted rules of courtesy which apply to all members of the Council, administrative staff, news media, citizens and visitors. These procedures provide:

- That no one shall delay or interrupt the proceedings, or refuse to obey the orders of the presiding officer.
- All persons should refrain from private conversation, eating, drinking and smoking while in the Council Chamber.
- Posters or placards must remain outside the Council Chamber.
- No cellular phones or audible beepers allowed in Council Chamber while City Council is in session.

"Citizens and other visitors attending City Council meetings shall observe the same rules of propriety, decorum and good conduct applicable to members of the City Council. Any person making personal, impertinent, profane or slanderous remarks or who becomes boisterous while addressing the City Council or while attending the City Council meeting shall be removed from the room if the sergeant-at-arms is so directed by the presiding officer, and the person shall be barred from further audience before the City Council during that session of the City Council. If the presiding officer fails to act, any member of the City Council may move to require enforcement of the rules, and the affirmative vote of a majority of the City Council shall require the presiding officer to act." Section 3.3(c) of the City Council Rules of Procedure.

Reglas de Cortesía

Las asambleas del Ayuntamiento Municipal reúnen a ciudadanos de diversos intereses e ideologías. Para asegurar la imparcialidad y el orden durante las asambleas, el Ayuntamiento ha adoptado ciertas reglas de cortesía que aplican a todos los miembros del Ayuntamiento, al personal administrativo, personal de los medios de comunicación, a los ciudadanos, y a visitantes. Estos reglamentos establecen lo siguiente:

- Ninguna persona retrasara o interrumpirá los procedimientos, o se negara a obedecer las órdenes del oficial que preside la asamblea.
- Todas las personas deben abstenerse de entablar conversaciones, comer, beber y fumar dentro de la cámara del Ayuntamiento.
- Anuncios y pancartas deben permanecer fuera de la cámara del Ayuntamiento.
- No se permite usar teléfonos celulares o enlaces electrónicos (pagers) audibles en la cámara del Ayuntamiento durante audiencias del Ayuntamiento Municipal

"Los ciudadanos y visitantes presentes durante las asambleas del Ayuntamiento Municipal deben de obedecer las mismas reglas de comportamiento, decoro y buena conducta que se aplican a los miembros del Ayuntamiento Municipal. Cualquier persona que haga comentarios impertinentes, utilice vocabulario obsceno o difamatorio, o que al dirigirse al Ayuntamiento lo haga en forma escandalosa, o si causa disturbio durante la asamblea del Ayuntamiento Municipal, será expulsada de la cámara si el oficial que este presidiendo la asamblea así lo ordena. Además, se le prohibirá continuar participando en la audiencia ante el Ayuntamiento Municipal. Si el oficial que preside la asamblea no toma acción, cualquier otro miembro del Avuntamiento Municipal puede tomar medidas para hacer cumplir las reglas establecidas, y el voto afirmativo de la mayoría del Ayuntamiento Municipal precisara al oficial que este presidiendo la sesión a tomar acción." Según la sección 3.3 (c) de las reglas de procedimientos del Ayuntamiento.

Handgun Prohibition Notice for Meetings of Governmental Entities

"Pursuant to Section 30.06, Penal Code (trespass by license holder with a concealed handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a concealed handgun."

"De acuerdo con la sección 30.06 del código penal (ingreso sin autorización de un titular de una licencia con una pistol oculta), una persona con licencia según el subcapítulo h, capítulo 411, código del gobierno (ley sobre licencias para portar pistolas), no puede ingresar a esta propiedad con una pistola oculta."

"Pursuant to Section 30.07, Penal Code (trespass by license holder with an openly carried handgun), a person licensed under Subchapter H, Chapter 411, Government Code (handgun licensing law), may not enter this property with a handgun that is carried openly."

"De acuerdo con la sección 30.07 del código penal (ingreso sin autorización de un titular de una licencia con una pistola a la vista), una persona con licencia según el subcapítulo h, capítulo 411, código del gobierno (ley sobre licencias para portar pistolas), no puede ingresar a esta propiedad con una pistola a la vista."

"Pursuant to Section 46.03, Penal Code (places weapons prohibited), a person may not carry a firearm or other weapon into any open meeting on this property."

"De conformidad con la Sección 46.03, Código Penal (coloca armas prohibidas), una persona no puede llevar un arma de fuego u otra arma a ninguna reunión abierta en esta propriedad."

- 1. seeking the advice of its attorney about pending or contemplated litigation, settlement offers, or any matter in which the duty of the attorney to the City Council under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with the Texas Open Meetings Act. - discussing or deliberating commercial or financial information that the city has received from a business prospect that the city seeks to have locate, stay or expand in or near the city and with which the city is conducting economic development negotiations; or deliberating the offer of a financial or other incentive to a business prospect. [Tex Govt. Code §551.087]
- deliberating security assessments or deployments relating to information resources technology, network security information, or the deployment or specific occasions for implementations of security personnel, critical infrastructure, or security devices. [Tex Govt. Code §551.089]

House Bill 14

- The bill adds a provision to the Local Government Code that if a regulatory authority does not approve a plat, plan, or development permit by the 15th day after the date prescribed for approval, the review may be conducted by someone who is NOT the applicant or a person whose work is the subject of the application; and IS:
 - an employee of the regulatory authority;
 - an employee of another political subdivision; or
 - a licensed engineer.





- Similarly, if a regulatory authority does not conduct a required inspection by the 15th day after the date prescribed for the inspection, the inspection may be conducted by someone who is NOT the owner of the land subject to the inspection; or a person who is the subject of the inspection, and who IS:
 - a certified building inspector;
 - an employee of the regulatory authority; or
 - an employee of another political subdivision under the same regulatory authority.






- The bill also makes decisions on development documents and inspections appealable to city council.
- Chapters 51A and 52 will need to be amended to incorporate the new timelines and establish an appeals procedure.





Development Services Performance Goals and Metrics and House Bill 14 Timelines



HB 14 Timeline Examples



- Texas Local Government Code § 214.904 requires a city to grant or deny a permit (or send the applicant a letter—see Example 2) within 45 days of receiving a complete application.
 - Day 1: application filed.
 - Day 45: deadline for approving or denying a permit.
 - Day 60: the applicant can hire a third party to review the application if the city has not approved or denied the application.



HB 14 Timeline Examples



- Under Texas Local Government Code § 214.904, if a city knows it will not be able to approve or deny the permit by the 45-day deadline, it can send the applicant written notice explaining why it has not been able to grant or deny the permit. If the city provides this notice, the permit must be granted or denied within 30 days of sending the notice.
 - Day 1: application filed.
 - Day 45: letter sent to applicant explaining why the city has been unable to grant or deny the permit.
 - 'Day 75: new deadline for approving or denying the permit.
 - Day 90: the applicant can hire a third party to review the application if the city has not approved or denied the application.



HB 14 Timeline Examples



- Texas Local Government Code § 212.009 requires a city to approve, approve with conditions, or deny a plat within 30 days of receiving a complete application. A plat is automatically approved if CPC fails to act on the application by the 30-day deadline.
 - Day 1: application filed.
 - Day 30: deadline for taking action on plat application.
 - Day 45: the applicant can hire a third party to review the application if the city has not approved or denied the application, but under the terms of § 212.009 the application will automatically be approved if the 30-day deadline is not met—this scenario would never come into play.



Notes & Next Steps



- While HB 14 provides that an applicant can hire a third-party inspector if an inspection is not completed by a deadline provided in the Texas Local Government Code, the Texas Local Government Code does not provide any deadlines for completing an inspection. This part of the bill has no application.
- The City Attorney's Office is working with city departments to draft code amendments.
- Code amendments will be briefed to the appropriate city council committees in the coming weeks.
