Texas Election Code, Chapter 67, Section 67.002{a}(2) states, in part, "Except as otherwise provided by law, the precinct election returns for each election shall be canvassed by the following authority ... for an election ordered by an authority of a political subdivision other than a county, the political subdivision's governing body. "Texas Election Code, Chapter 67, Section 67.004{a} further states, in part, "... Two members of the authority constitute a quorum for purposes of canvassing an election."
