The Inspector General, Dallas City Attorney's Office, on behalf of the City of Dallas, presents in and to the Ethics Advisory Commission, City of Dallas that:

ON OR ABOUT AND BETWEEN APRIL 8, 2023, AND JUNE 8, 2023, KNOWINGLY OR WITH KNOWLEDGE, IN THE PERFORMANCE OF HER OFFICIAL DUTIES, ALLOWED CUSTOMERS INTO THE WORKSITE LOCATED AT 5100 YOUNGBLOOD ROAD, DALLAS, TEXAS WITHOUT PAYING, AND TOOK PAYMENTS BELONGING TO THE CITY OF DALLAS AND PLACED THEM INTO HER POCKET AT 5100 YOUNGBLOOD ROAD, DALLAS, TEXAS,

in violation of Dallas City Code, Chapter 12A, "Code of Ethics," Section 12A-3, "Fiduciary Duty"; Section 12A-4, "Standards of Behavior; Standards of Civility," to wit:

Ethics Violation 1: A city official and employee, in the performance of his or her official duties, shall fulfill his or her fiduciary duty to the city, in violation of Sec. 12A-3; and

Ethics Violation 2: City officials and employees shall, when acting in the performance of their official duties, comply with the following standard of behavior: to conduct themselves and to operate with integrity and in a manner that merits the trust and support of the public, in violation of Sec. 12A-4(a)(1); and

Ethics Violation 3: City officials and employees shall, when acting in the performance of their official duties, comply with the following standard of behavior: to take no actions that could benefit the official or employee personally, or his or her relative, to the detriment of the city, avoiding even the appearance of a conflict of interest, and to always exercise good judgment, in violation of Sec. 12A-4(a)(5); and

Ethics Violation 4: City officials and employees shall, when acting in the performance of their official duties, comply with the following standard of behavior: to carefully consider the public perception of personal and professional actions and the effect such actions could have, positively or negatively, on the city's reputation both in the community and elsewhere, in violation of Sec. 12A-4(a)(6).
