**EXTENSION OF THE PROCLAMATION DECLARING A
LOCAL STATE OF DISASTER**

BE IT REMEMBERED:

WHEREAS, as of March 19, 2020, Dallas County Health and Human Services (DCHHS) has confirmed a total of 55 positive cases of a novel coronavirus (COVID-19) in Dallas County; and

WHEREAS, on March 12, 2020, the first "presumptive positive" case with evidence of community spread was reported; and

WHEREAS, actions toward response and recovery must be continued by the consent of Council as hereby provided, in order to mitigate the spread of COVID-19 and respond to the existing outbreak, and related peril that will occur; and

NOW, THEREFORE, by virtue of the authority vested in me, by the Dallas City Charter, as the presiding officer of the governing body, the City Council of the City of Dallas, a home-rule city, municipal corporation, body politic, and political subdivision of the State of Texas situated in Dallas, County, Texas, and upon the consent of the City Council of the City of Dallas pursuant to Section 14B-6 of the Dallas City Code and pursuant to Section 418.108 of the Texas Government Code (Texas Disaster Act of 1975), I hereby extend the proclamation declaring a local state of disaster within the City to continue until April 29, 2020, at 11:59 p.m.

ACCORDINGLY, I further proclaim the continuation of the City Emergency Management Plan and the continuation of all other Charter, statutory, and ordinance powers vested in me and all officers of the City of Dallas to act in the premises and for the purposes stated.


Prompt and general publicity is hereby proclaimed and ordered as to the continuation of this Proclamation.


